The Canada Gairdner International Award recognizes outstanding **biomedical scientists** who have made original contributions to medicine with the goal of contributing through research to increased understanding of human biology and disease. Nominees should be individuals whose *"seminal discoveries and major scientific contributions constitute an original and significant achievement in biomedical science."* Nominations in the field of translational research are welcome. The award does not recognize a lifetime of work.

The Gairdner Foundation was established in 1957 with the main goal of recognizing and rewarding international excellence in fundamental research impacting human health. There are five awards for biomedical research. Laureates each receive \$100,000 CDN that can be put towards anything the laureate wishes. Past laureates have used their winnings to support their labs or their research.

Nominations should be accurate, detailed, current, complete, and with supporting letters reflecting the nominee's accomplishments.

10/31/2020 Ho Am Prize in Medicine

The Ho-Am Prize was established in 1990 by Kun-Hee Lee, the Chairman of Samsung, with a vision to create a new corporate culture that continues the noble spirit of public service espoused by the late Chairman Byung-chull Lee, founder of Samsung.

The Prize, named after the late Chairman's pen name, is presented each year to individuals who have contributed to academics, the arts, and social development, or who have furthered the welfare of humanity through distinguished accomplishments in their respective professional fields.

The Prize for Chemistry and Life Sciences includes such fields as organic chemistry, inorganic chemistry, biochemistry, life sciences and integrated sciences. **The prize is presented to people of Korean heritage** who made significant progress in these basic fields.

The Prize for Medicine includes the clinical and research areas of medicine, physiology, and pharmacology. **The Prize is awarded to people of Korean heritage** who have made distinctive contributions to the efforts of humankind to conquer the disease.

Recipients of the Ho-Am Prize are presented with a diploma, a pure gold medal, and a cash prize of approximately \$275,000. The nomination deadline is **October 31, 2020**.

Unlike other international prizes which have specific fields, the LUI Che Woo Prize is a new and prestigious international accolade awarded to individuals or organizations who have displayed

remarkable achievements towards the three objectives of the Prize thereby contributing to world civilization. Thus, the coverage of the LUI Che Woo Prize is very broad, the recipients not being limited to academics and scientists. The LUI Che Woo Prize recognizes accomplishments beneficial to mankind and also encourages the continuation of that work for which its laureates have been chosen. It transcends all boundaries of nations and sows seeds for the continuous development of a better and harmonious world.

There are three Prizes for the three objectives of the LUI Che Woo Prize (each a "Prize Category") every year. If there is no appropriate awardee for any Prize Category in any particular year, no Prize will be awarded for that Prize Category in that year.

Each awardee will receive a cash award of HK\$20 million (equivalent to approximately US\$2.56 million), a certificate and a trophy.

The Shaw Prize is an international award to honor individuals who are currently active in their respective fields and who have recently achieved distinguished and significant advances, who have made outstanding contributions in academic and scientific research or applications, or who in other domains have achieved excellence. The award is dedicated to furthering societal progress, enhancing quality of life, and enriching humanity's spiritual civilization.

The Shaw Prize consists of three annual awards: the Prize in Astronomy, the Prize in Life Science and Medicine, and the Prize in Mathematical Sciences. Each prize carries a monetary award of one million two hundred thousand US dollars. The nomination process begins in September, the winners are announced in the following summer and the prizes are presented in autumn.

The Shaw Prize, established under the auspices of Mr Run Run Shaw in November 2002, is managed and administered by The Shaw Prize Foundation based in Hong Kong.

The Prize in Life Science and Medicine:

Discoveries in **the biomedical sciences and innovations in clinical medicine** have led to significant victories in our longstanding war against illness and suffering. With the mapping of the entire human genome, we are now closer to the understanding of the mechanisms of life, aging, illness and death, opening up exciting new opportunities for advances in therapeutics. Novel insights in the life science and technological advances in medicine will result in better health and an improved quality of life for the human race in the new century.

12/01/2020 Alfred W. Bressler Prize in Vision Science

The Bressler Prize in Vision Science was established in 2001, and since 2003 has annually recognized a **mid-career vision clinician or scientist** whose leadership, research and service have led to substantive advancements in the understanding of vision loss, treatment of eye disease, or the rehabilitation of people with vision loss.

The Bressler Prize includes an unrestricted cash award of \$54,000 which is presented in conjunction with a scientific symposium. The recipient is invited to join the selection committee for subsequent years' deliberations.

Open to established mid-career vision clinicians or scientists whose leadership, research and service have led to substantive advancements in the understanding of vision loss, the treatment of eye disease or the rehabilitation of people with vision loss. Nominees should be clinically and/or scientifically accomplished, and generally under-recognized in his/her respective fields. Scientific accomplishment must exhibit immediate clinical relevance.

12/02/2020 Technological Innovations in Neuroscience Awards

LOIs are due December 7, 2020.

Full proposals will be due April 26, 2021.

Technological Innovations in **Neuroscience** Awards support scientists who work on novel and creative approaches to understanding brain function. The program seeks to advance and enlarge the range of technologies available to the neurosciences. It does not support research based primarily on existing techniques.

The Endowment Fund is especially interested in how technology may be used or adapted to monitor, manipulate, analyze, or model brain function at any level, from the molecular to the entire organism. Technology may take any form, from biochemical tools to instruments to software and mathematical approaches.

A goal of the Technological Innovations awards is to foster collaboration between the neurosciences and other disciplines; therefore, collaborative and cross-disciplinary applications are explicitly invited.

Established in 1999, the Technological Innovations in Neuroscience Awards provide up to \$100,000 per year for two years. Each year, up to three awards are given. Funds may be used toward a variety of research activities but not the recipient's salary.

12/15/2020 Viktor Hamburger Outstanding Educator Prize

Established in 2002 by the Board of Directors and sponsored by the Professional Development and Education Committee of the Society for Developmental Biology (SDB), this award recognizes individuals who have made outstanding contributions to **developmental biology education.**

A nominee must have made outstanding contributions to education in developmental biology or related disciplines. Contributions will be construed in the broadest context and may include teaching at any level; training professionals; organizing and administrating programs; Integrating developmental biology into our educational system; or disseminating reliable information to professional members, to prospective developmental biologists, to students in other fields, or to the general public. The prize winner must be able to deliver the award lecture at the SDB Annual Meeting.

The Prize, a gold medal and unrestricted \$500,000 cash award is awarded for fundamental insights in the field of genetics. These may include original discoveries in genetic function, regulation, transmission, and variation, as well as in genomic organization.

The Prize carries a cash award of \$150,000 and a silver medal in the design of a Roosevelt dime, to commemorate of our founder, President Franklin D. Roosevelt. Nominees should be scientific leaders who have pioneered research to advance our understanding of prenatal development and pregnancy.
