The JHU Tax Office offers tax workshops each year for nonresident student and scholars. The purpose of these workshops is to provide information to the JHU international population in order to aid in their tax return preparation. Although the Tax Office does not prepare or review tax returns, the workshop provides a venue to ask the staff general questions relating to income tax preparation. At the workshops, the Tax Office will provide a worksheet explaining how information on a W2 and/or 1042S relates to the tax filer's federal 1040NR or 1040NR-EZ and state income tax forms. As JHU no longer receives federal and state forms, it is the student/scholars responsibility to bring the appropriate forms to the sessions.
