Description

Colorectal cancer is one of the most common types of cancer in the United States. It is the third most common type of cancer and the third leading cause of cancer-related death in the Western world. In 2010, there were an estimated 142,570 new cases of colon and rectal cancer, with 51,370 deaths due to colon and rectal cancer combined. It is, however, one of the most potentially curable of gastrointestinal cancers. Screening is vital to prevention and should be a part of routine care for adults over the age of 50 who are at average risk. High-risk individuals (those with previous colon and/or rectal cancer, family history of colon and/or rectal cancer, inflammatory bowel disease, or history of colorectal polyps) require careful follow-up and, if necessary, screening prior to the age of 50. There have been many new discoveries in this disease in recent years and management options have evolved significantly. This course will focus solely on colorectal cancer and will address important current concepts in the multidisciplinary management of the disease. It has been carefully organized to foster interaction between faculty and participants and will provide a venue for discussion so that physicians are able to diagnose and treat their patients more effectively when returning to their practice.

Who Should Attend

This activity is intended for gastroenterologists, surgeons, medical oncologists, radiation oncologists, radiologists, pathologists, nurses, nurse practitioners, physician assistants, social workers and other healthcare professionals involved with the diagnosis, treatment and follow-up of patients with, or at risk for, colorectal cancer.

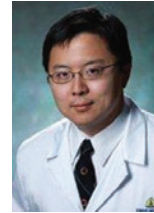

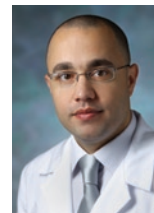

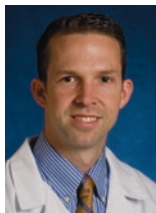
