Dear Prospective Students,

The Department of Emergency Medicine at the Johns Hopkins University School of Medicine is pleased to accept applications for our Visiting Elective Program to Promote Diversity, Equity, and Inclusion in Emergency Medicine. Johns Hopkins Emergency Medicine is committed to cultivating and sustaining an environment that fosters the development of physician leaders who are dedicated to eliminating the nation's health inequities through patient care, education, advocacy and research.

Our scholarship provides financial assistance for senior medical students planning careers in emergency medicine who share these goals. The scholarship provides a stipend of \$2,000 to offset the cost of housing and other expenses related to the visiting clerkship. In addition to an outstanding clinical experience in one of the nation's top Emergency Medicine programs, students will be given opportunities for mentorship from our esteemed faculty with wide ranging interests including medical education, hospital administration, global health, the health humanities, and social emergency medicine.

Diversity, equity and inclusion are core values of our education program, and we are thrilled to welcome all applicants regardless of race, ethnicity or socioeconomic status. Additionally, applicants from backgrounds underrepresented in medicine are encouraged to apply. According to the AAMC (Association of American Medical Colleges), "Underrepresented in medicine means those racial and ethnic populations that are underrepresented in the medical profession relative to their numbers in the general population."

All students applying for the scholarship must meet these criteria:

- 1. Senior medical student in good standing at an accredited U.S. medical school
- 2. Eligible for acceptance into the Johns Hopkins Advanced Clerkship in Emergency Medicine (satisfactory completion of core clerkships in medicine, surgery and emergency medicine)
  - a. Please note that due to the level of autonomy and responsibility afforded our advanced clerkship students, we require that students have already completed a prior clerkship in emergency medicine. We understand that some students may not have completed a clerkship at the time of application, and we are happy to offer provisional acceptance to the program pending the satisfactory completion of this pre-requisite. Students should *not* be discouraged from applying based on this requirement.
- 3. Demonstrated commitment to diversity, equity, and inclusion in medicine as evidenced through leadership activities, community engagement, advocacy, scholarship, or other activities
