responsible for examining 35 patient records, yielding 46 separate reviews of 4 providers (2 psychiatrists, 1 perinatologist, 1 obstetrical nurse practitioner). 10 charts failed the documentation requirements: 6 lacked documentation of pertinent therapeutic monitoring, 1 lacked documentation of adverse effects of new medications, 1 lacked documentation of rationale for medication change, and1 lacked documentation of rationale for high-dose/multiple medications. On the basis of this project, the existing psychiatry evaluation and follow-up forms were replaced with new forms to include prompts for documentation of these items. In addition, all Center for Addiction and Pregnancy psychiatrists and obstetrical providers were educated about the importance of such documentation, and psychiatrists were educated about how to complete the new forms and obstetrical providers were educated about how to document these items in the QS electronic medical record system.

As the sole behavioral health consultant for the Health Services Advisory Group Incorporated, I developed and reviewed all behavioral health protocols for the Maternal Opiate Medical Supports (MOMS) Project. This 2-year quality improvement initiative -sponsored by the Office of Health Transformation, Ohio Department of Mental Health and Addiction Services, and Ohio Department of Medicaid - sought to improve maternal and fetal health outcomes, improve family stability, and reduce costs of neonatal abstinence syndrome by providing treatment to pregnant mothers with opioid dependence during and after pregnancy through a maternity care home model of care in the state of Ohio. The National Governor's Association for Best Practices (NGA) recently completed a competitive application process for states to participate in a new project – Addressing Maternal Opioid Use Disorders to Prevent and Reduce the Effects of Neonatal Abstinence Syndrome. Five states have been selected (Alaska, Arizona, Missouri, Rhode Island, and West Virginia), and the MOMS Project will serve as the best practice for other states.
