<p>The Whole Health Assessment (WHA) program is designed to assist our Johns Hopkins (JH) Advantage MD Primary Care providers in capturing the health conditions and to close gaps in care during annual face to face visits with our Advantage MD members.</p> <p>The completion of the WHA form will not only assist in attaining the best health outcome for our members, but also assist Johns Hopkins HealthCare LLC (JHHC) in improving our benefits, care coordination, and care management programs.</p> <p>For your efforts in completing the WHA form, a one-time per calendar year reimbursement of \$150 will be paid to your office for your Advantage MD members.</p>	<ul style="list-style-type: none"> <li>Download the WHA form from the JHHC website at <a href="http://www.jhhc.com">www.jhhc.com</a> using following path: For Providers/Our Health Plans/Advantage MD/Forms</li> <li>Complete the entire one page WHA form and return the form via fax along with the progress notes and any applicable results.</li> <li>Complete all member demographic information</li> <li>Include the date of service Sign and date your completed note to include your medical designation i.e. credential. Ex. MD, PA, NP or OD</li> <li>Strike through and initial any errors</li> <li>Include two patient identifiers on each page of the progress note</li> <li>Use practice standard abbreviations</li> </ul>	<p>Submit a CMS 1500 through the normal claims submission process using billable code <b>“G9008.”</b></p> <p>Fax the completed WHA form along with the supporting progress notes and applicable test results to: Fax <b>(844) 303-1716</b></p> <p>Bill with the appropriate level office visit for services rendered:</p> <ul style="list-style-type: none"> <li>99201- 99215 Routine physician visit</li> <li>G0402 Welcome to Medicare</li> <li>G0438, G0439 Annual Wellness Visit</li> <li>99381-99397 Annual physical exam</li> </ul> <p><i>*Your office will be notified of any incomplete forms or if a claim is submitted and no WHA form received.</i></p>	<p><b>Q. How often can I bill for the WHA for my Advantage MD member?</b> <i>A. Once per calendar year.</i></p> <p><b>Q. What is the reimbursement for the WHA?</b> <i>A. \$150. You will also receive payment for the office visit by billing the appropriate E&amp;M code.</i></p> <p><b>Q. How do I bill for the WHA?</b> <i>A. The claim should be billed using code “G9008”.</i></p> <p><b>Q. Is the WHA for all lines of business?</b> <i>A. No, just JH Advantage MD.</i></p> <p><b>Q. If I bill an annual wellness visit with the G9008 code, will I need a modifier?</b> <i>A. No, but if you bill two visit codes, then a modifier is needed.</i></p> <p><b>Q: How is this data helpful and what does JHHC do with it?</b> <i>A. The form provides accurate coding and documentation to close gaps in care.</i></p>
