

Provider Update

This update contains pertinent information about changes that will impact the Johns Hopkins HealthCare provider network.

Reminder: JHHC and CVS Health-NovoLogix Partnership for Preauthorization of Medical Injectables Goes Into Effect In July

Health Plans Affected*: Johns Hopkins Advantage MD, Johns Hopkins Employer Health Programs (EHP)** and Priority Partners.

Explanation of Change: As of July 15, 2021, preauthorization will be required for the medical injectable drug codes listed in the below links for Johns Hopkins EHP** and Johns Hopkins Advantage MD. Providers may request preauthorization through CVS Health–NovoLogix for these health plans as of July 1, 2021 for service dates of July 15, 2021 and later. The process for obtaining prior authorizations for Johns Hopkins EHP** and Johns Hopkins Advantage MD will be managed in collaboration with CVS Health–NovoLogix. Additionally, Priority Partners will be moving its direct prior authorization services to the CVS Health-NovoLogix platform. Preauthorization requirements for select drug codes (see link below) are already in place—and will remain in place—for Priority Partners. Therefore, providers may request preauthorization through CVS Health–NovoLogix for Priority Partners for service dates July 1, 2021 and later.

*There are no changes for Johns Hopkins US Family Health Plan (USFHP).

**Employees of Johns Hopkins University covered under EHP will be excluded from these preauthorization requirements.

How to Request Prior Authorization:

Providers may submit preauthorization requests electronically through NovoLogix using the [JHHC HealthLINK](#) secure portal. The NovoLogix portal must be accessed through HealthLINK for JHHC preauthorization requests. This is the preferred and most efficient method of submission.
